3. Purpose and legal basis of data processing

Purpose:

Disposal of municipal building plots in accordance with the relevant guideline for the allocation of plots.

Legal basis:

Your data will be stored in accordance with art. 6 para. 1 General Data Protection Regulation (GDPR) in conjunction with art. 4 para. 1 Bavarian Data Protection Act, art. 6, 7, 21, 22, 23, 24, 56, 57 and 62 Local Government Law, and s. 1, 17 and 22 Law on Inter-Municipal Cooperation, as well as private-law agreements in accordance with s. 311b, ss. 535 - 548, ss. 585 - 597, ss. 873 - 902, ss. 1018 - 1104 German Civil Code and s. 4 Regulations on Automated Retrieval of Personal Data from the Land Survey Register.

4. Recipient of personal data

In case your personal data has to be verified in accordance with the registration law, your data may be transferred to the registration office of the Town of Herzogenaurach as well as to the registration offices of other municipalities.

In case of purchase of a plot, your personal data will be transferred to the notary's office in Herzogenaurach for the purpose of preparation of the purchase contract.

After receipt of a separate statement of consent, your contact data will be transferred to potential neighbors.

5. Period of storage of personal data

Personal data will be stored until failure to fulfill the requirements.

6. Rights of the data subject

In accordance with the General Data Protection Regulation, you have the following rights:

If your personal data is being processed, you are entitled to receive information about what data relating to your person has been stored (art. 15 GDPR).

In case inaccurate personal data has been processed, you are entitled to obtain rectification of the relevant data (art. 16 GDPR).

If the relevant statutory prerequisites are given, you are entitled to obtain the erasure or limitation of processing, and may object to the processing (art. 17, 18 and 21 GDPR).

If you consented to the data processing or if there is a data processing agreement, and if the data processing is performed by means of automated systems, you may have a right to data portability (art. 20 GDPR).

If you want to make use of these rights, the relevant authority will check whether the necessary legal grounds are given.

Additionally, you are entitled to file a complaint with the Bavarian State Officer for Data Protection.

7. Obligation to provide relevant data

The provision of all relevant data is a prerequisite for being entered on the list of applicants for building plots sold by the Town of Herzogenaurach.

8. Right of withdrawal of consent

If you have consented to the processing of your data by the Town of Herzogenaurach by means of a corresponding statement, you have the right to withdraw such consent at any given time. In case you withdraw your consent to the processing of personal data, you will be removed from the list of applicants for building plots sold by the Town of Herzogenaurach.
