# Stadtentwässerung

The Department for Wastewater Treatment in Herzogenaurach has assumed the statutory communal duty of wastewater treatment.

The corresponding details have been specified in the framework of the Regulations on the Public Sewerage System of the Town of Herzogenaurach in connection with the Regulations on Contributions and Fees for the Sewerage Regulations.

The Department for Wastewater Treatment is a cost account- based institution exclusively refinanced by fees and contributions.

## Wastewater fee

As of April 1, 2010, the wastewater fee is EUR 2.28 per m<sup>3</sup> of freshwater purchase. Freshwater purchase is defined as any amount of water obtained from the public drinking water supply system or from private water recovery systems (e.g. rainwater cisterns or wells).

## Rainwater fee

As of April 1, 2010, the rainwater fee is EUR 0.35 per m<sup>2</sup> of paved and sewage-effective area. Permanently installed rainwater collection systems are taken into account for the calculation of fees (reduction of 10m<sup>2</sup> per m<sup>3</sup> of year-round available capacity).

## Connection contribution

The sewer connection contribution is EUR 8.15 per m<sup>2</sup> of floor area; EUR 2.22 per m<sup>2</sup> of plot area (subject area Building code, traffic, contributions).

For **private property drainage systems**, the relevant valid regulations of ss. 9

to 13 of the Sewerage Regulations apply. (subject area Department for Civil Engineering)
